All Teaching Specialist and Public Health Specialist may note that the Delhi Health Service (Allopathy) Rules, 2009 were notified in Delhi Gazette Extraordinary on 23/12/2009. Vide letter no. A.12034/2/2005-CHS-V dated 27/09/2011 issued by Joint Secretary, Ministry of Health & Family Welfare, Government of India, the consent of Ministry to the inclusion of the posts of Teaching & Public Health Specialist sub-cadre in Delhi Health Service has been conveyed. Accordingly, all the Teaching Specialist and Public Health Specialist appointed under the Central Health Service Rule, 1996 who are working in the Government of NCT of Delhi as on the date of publication of this notice may opt for inclusion in DHS Cadre. Consequently, all such officers shall be deemed to have been appointed under these rules and they shall be members of the service in the respective sub-cadre.

The format for exercising above mentioned option is enclosed and is also available on the website of Health & Family Welfare, Government of NCT of Delhi at www.delhi.gov.in. The said option should reach to the office of Pr. Secretary (H&FW), Government of NCT of Delhi, 9th level, A-wing, Delhi Secretariat, New Delhi-110002, latest by 15/05/2012.
