ORDER

Sub: - Cancellation of Promotion of promoted teachers of MCD vide order No. 02 (11-12) dated 11/12/12 to the post of TGTs in DOE.

A total of 1357 Assistant Teachers of MCD were promoted to the post of TGT/TGTs (MIL) in the pay scale of Rs. 9300-34800/- + Grade pay 4600 /- plus usual allowances as admissible under the rules vide Establishment III Branch, Old Secretariat, Delhi, order No.02(11-12) dated 11/12/12.

During the scrutiny, it is found that the names of some promoted Assistant Teachers of MCD are found repeated in the promotion order. The same were put up before the Competent Authority for cancellation. The Competent Authority has accepted the proposal for cancellation of promotion with retrospective date. The promotion of these Assistant Teachers (repeated) may be treated as cancelled with retrospective date now and no further request/representation in this regard will be entertained.
