ORDER

Whereas Sh. Shayam Lal, Group-D Employees of Lok Nayak Hospital was recommended by DPC for promotion to the post of Laboratory Assistant in Directorate of Education and his promotion order was issued vide order No.DE.4(8)/23/E-IV/2010/333-398 dated 7.1.2013 on the basis of information/documents duly forwarded by Director (Admn.), LN Hospital vide letter dated 15.6.2012.

And while forwarding his name by Lok Nayak Hospital, it was intimated that no departmental inquiry/disciplinary proceeding is pending against said Sh. Shyam Lal, Chowkidar/Group-D and it was also informed in the prescribed format that said Sh. Shyam Lal is clear from vigilance angle, Work & Conduct is also satisfactory and fit for promotion.

And after issuance of promotion order, DOE requested concerned HODs vide order No.DE-4(8)/(23)/E-IV/2010/1978-2007 dated 1.4.2013 to relieve the concerned employee and it was requested that it may be ensured before relieving that no vigilance case is contemplated/pending against him at any level. Accordingly, Sh. Shyam Lal, Chowkidar was relieved by LN Hospital vide order F.No.83/E-II/LNH/2012-13/624 dated 12.4.2013 directing said Sh. Shyam Lal, Chowkidar to report for duty in DOE and in pursuance of this relieving order, Sh. Shyam Lal, Chowkidar has joined his duty as Lab. Assistant on 12.4.2013 in DOE. However, his posting orders as Laboratory Assistant have not been issued by DOE till date.

And whereas, LN Hospital, later on, has informed that relieving order F.No.83/E-II/LNH/2012-13/624 dated 12.4.2013 in respect of Sh. Shyam Lal is withdrawn with retrospective effect since as per Vigilance Branch of LN Hospital, a case pertaining to the year 1997 and FIR NO.531 dated 8.10.1997 is pending against him. LN Hospital has also requested to issue direction to said Sh. Shyam Lal to join LN Hospital.

Now, In view of the facts & circumstances, the promotion order No. DE.4 (8)/23/E-IV/2010/333-398 dated 7.1.2013 to the post of Laboratory Assistant in respect of Sh. Shyam Lal, are hereby cancelled with retrospective effect. Further, said Sh. Shyam Lal is hereby relieved with retrospective effect to his parent post i.e. Chowkidar/Group-D and he is hereby directed to report back to his parental Department i.e. LN Hospital with immediate effect to the post of Chowkidar/Group-D.

This issues with the prior approval of Competent Authority.
