ORDER


In pursuance to the Gazette Notification dated 23-10-2012 imposing ban on manufacture, sell, use, storage, import & transport of any kind of plastic carry bags (including that of polypropylene, non-woven fabric type carry bags) as well as use of any kind of plastic cover or plastic sheet or plastic film or plastic tube to pack or cover any book including magazine, and invitation or greeting card, in whole of NCT of Delhi, coming into force w.e.f. from 23-11-2012, the following officers are authorized for implementation of the ban as per the following schedule:


