ORDER

No. F.3(4)/2002/F&S/P&C/Vol.I: Whereas the Lt. Governor of the National Capital Territory of Delhi rescinded the Delhi Edible Oils (Licensing and Control) Order, 1977, vide Order No.F.3(1)/97-F&S(P&C)/(ii)/252 dated 9th March, 1998 and the Delhi Pulses (Licensing of Dealers) Order, 1974 vide Order No.F.3(17)/2003/F&S/Policy//206 dated the 12th July, 2004.

Whereas the Central Government vide Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs, Notification No. S.O. 2927(E) dated 27.09.2013 has issued the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Amendment) Order, 2013;

And whereas clause 1(1), 1(2) and 2 of the aforesaid Order provides:-

1.(1) This Order may be called the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on specified Foodstuffs (Amendment) Order, 2013.

(2) It shall come into force on the 1st day of October, 2013.

2. In the Removal of (Licensing Requirements, Stock Limits and Movement Restrictions) on Specified Foodstuffs Order, 2002, in clause 7 as inserted by notification of Government of India with Ministry of Consumer Affairs, Food and Public Distribution, Department of Consumer Affairs published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), vide number S.O. 654(E), dated 30th March, 2011, in sub-clause (1), for item (i), the following item shall be substituted, namely:-


“(i) pulses, edible oils and edible oilseeds for a period up to 30th September, 2014.”

Now, therefore, the Lt. Governor of National Capital Territory of Delhi, in exercise of the powers conferred by section 3 of the Essential Commodities Act, 1955 (10 of 1955) read with the order issued by the Government of India, Ministry of Agriculture (Department of Food) Notification No.G.S.R.800 dated the 9th June, 1978, hereby orders that Order No.F.9(1)97-F&S(P&C)/(ii)/252 dated the 9th March, 1998 and Order No.F.3(17)/2003/F&S/Policy//206

dated 12th July, 2004 relating to the Delhi Edible Oils (Licensing and Control) Order, 1977 and Delhi Pulses (Licensing of Dealers) Order, 1974 respectively, shall be kept in abeyance, to the extent of the provisions of the Removal of (Licensing requirements, Stock limits and Movement Restrictions) on Specified Foodstuffs (Amendment) Order 2013, dated 27.09.2013 for a further period up to 30th September, 2014 in respect of edible oils, edible oilseeds and pulses.
