Sub.: Review of Revision of Pension cases of the pre-2006 pensioners

Sir/Madam,

Government of India, Ministry of Personnel, Public Grievances & Pensions, Department of Pension & Pensioners' Welfare in para 8. of their Office Memorandum dated September 1, 2008 have authorized all Pension Disbursing Authorities including public sector banks handling disbursement of pension to the central government pensioners to pay pension/family pension to the pensioners/family pensioners retired prior to January 1, 2006 at the consolidated rate in terms of para 4.1 of the O.M referred to above without any further authorization from the Accounts Officer/Head of Office etc concerned.

2. As per para 11 of their above referred O.M, it shall also be the responsibility of the Head of Department from where the government servant retired/died to revise the pension/family pension of all pensioners/family pensioners w.e.f. January 1, 2006 in accordance with the provisions mentioned in para 4.1. and 4.2 of the O.M referred to above.

3. In order to ensure the updation of pension records of the pre-2006 pensioners, the Central Pension Accounting Office, Ministry of Finance has advised all the Pay & Accounts Offices to carry out the revision of pension of such pensioners online on the software "e-Revision Utility".

4. The existing pension records of the pre-2006 pensioners/family pensioners do not contain details such as date of birth of the family members, BSR (Bank Statistical Return) Code. Therefore the Government of India have advised all the pensioners/family pensioners to provide these details along with other details in the prescribed application form.

5. The Controller General of Accounts, Ministry of Finance has pointed out that revision of pension/updation of pension records of 54086 pre-2006 pensioners/family pensioners and of 408 post 2006 pensioners/family pensioners in respect of the various departments of the GNCT of Delhi is still to be carried out.
