1. They shall be required to deposit earnest money with each application of tender, as per terms and conditions of the Notice Inviting Tenders .
- b) Security deposit will be recovered from their running bills in accordance with the rules in force time to time.
2. They shall employ the required technical staff and /or tools & plants as per terms and conditions of each contract/agreement.
3. They shall abide by the terms and conditions of the NIT/Contract/Agreement as they stand or as may be altered from time to time.
4. They shall not modify the existing partnership or enter into any fresh partnership without prior approval of the enlistment authority. Such proposal if any shall be submitted in advance, giving full details of the intended partnership/sole proprietorship along with the draft partnership deed/affidavit and as an "individual" or in constitution of the firm without prior approval of the enlistment authority will render the contractor/firm liable to be removed from the approved list of contractors.
5. They shall not be permitted to tender for works in Irrigation & Flood Control Department of Delhi, responsible for award and execution of contract in which their near relative is posted as Divisional Accountant as an officer between the grades of Superintending Engineer and Jr. Engineer (Both Inclusive). They shall also intimate to this department the names of persons who are working with them and who are near relatives of any Gazetted officer in Irrigation & Flood Control Department. Any breach of the conditions by contractor shall render them liable to be removed from the approved list of contractor of the department.

6. The enlistment notified in this order is valid for a period of five years from the date of approval. The contractors will be required to apply for revalidation of their enlistment in the prescribed form along with all required documents so as to reach the enlistment authority at least six months before the date of expiry of his enlistment.
7. They are required to secure work in this department. In case they fail to secure any work specified magnitude during the period of enlistment /revalidation the enlistment of the contractor is liable to be not revalidated
8. They shall also intimate the change in their address (Registered office/ Head office) if any, in future and in case they fail to intimate such change to the department their name would be removed from the approved list of the contractor.
9. They shall be bound by the enlistment rules of the department as amended from time to time.


