**ORDER**

**Subject: Registration of Public Service Vehicles in Delhi**

In continuation to the order no. F 23 (423)/TPT/OPS/2009/272-302 dated 09/01/2013 and in supersession of order no. F.20 (423)/Tpt/OPS/2009/603-24 dated 15.1.2013, to streamline the process of police verification of intending owner, before registration/transfer of ownership, it has been decided by the Government that -

1. In case of following, it would be treated as deemed to be Police Verification for the purpose of registration of Public Service Vehicles:

a. If the owner is having a valid passport for that particular address where the vehicle is going to be registered, submission of a self attested copy of passport alongwith online SCRB report of conviction / involvement and production of original passport before the registering authority.

b. If the owner is having a valid Driver Public Service Badge(PSB) issued by the Transport Department, Delhi

c. Submission of a valid certificate, not older than six months, issued from police authority (not below the rank of ACP) certifying the residential address of the owner alongwith online SCRB report of conviction / involvement.

In case of registration of additional Public Service Vehicle (PSV) in the same name & address, these documents will not be required again for a period of one year from the date of issuance of such certificate by the concerned Police Authorities. However, the applicant has to submit self- attested photocopies at each occasion.

2. The exercise of police verification is not required in case of the vehicles owned by following:-

- Central Government and State Government
- Public Sector Undertakings/Autonomous Bodies of Central and State Governments
- Local Bodies
- Recognized Educational Institution
- Authorized Motor Driving Training Schools
- Cluster Bus Operators approved by the Transport Department of Delhi

- Hotels/Tourist Transporters approved by the Ministry of Tourism / Govt. of Delhi/ DTTDC
- Approved/Registered Hospitals & Nursing Homes
- Approved Radio Taxi / Rent a cab operators
