
ISSUANCE OF PSV BADGES FOR DRIVER'S ENGAGED BY CORPORATE OPERATOR'S

It has been decided that the PSV Badge for the drivers engaged by corporate operator of Public Service Vehicles i.e Taxi/ Buses/TSR be issued subject to undertaking (Performa enclosed) furnished by these operators' (Depot Manager (in case of DTC), CEO/ Managing Director/ Owner) regarding antecedents and character of said driver.

Further, the name of operators' who furnish the undertaking shall be mentioned on the badge and will be valid to drive the PSV vehicle of the said operator only.

After issue of badge, matter may be referred to Police authorities immediately for verification within 30 days. MLO concerned shall make sure that the letter is delivered to concerned police authority. In case, no response is received from the Police, it shall be presumed that no adverse entry is available against the applicant.
