6. If he/she remains absent continuously from his/her duty for more than 30 days or more without any information /permission, his/her liable to be terminated.
7. In case he/she is already employed, he /she should produce a No Objection Certificate/relieving report from the previous employer.
8. In case of failure on any of the above counts, M/Roll engagement shall liable to be terminated without any notice.
