

Terms & Conditions.

2. The above promotion will be also subject to final outcome of Writ Petition filed by Shri A.K.Awasthi and others before Hon'ble High Court, Delhi or any other.
3. The ad-hoc promotion will not confer any right on the officer to claim for regular promotion to the post or any other service benefit.
4. The period of service rendered on ad-hoc will not count on officiation in the higher grade for any purpose.
5. The Competent Authority can terminate the interim arrangement at any time without assigning any reason and giving any prior notice.
6. Other conditions of service will be governed by the relevant rules and orders that may be in force from time to time.
7. The ad-hoc promotion is also subject to various court cases pending, if any, in the Hon'ble High Court of Delhi/Central Administrative Tribunal.
