- (a) Pay & allowances of the incumbents will be fixed under the provisions of FR-22 (1) a (1) subject to the terms and conditions contained in Circular No. DJB/AC(W)/ACP/99/7377 dt. 30.11.99 and further clarification issued vide circular No. DJB/AC(W)/2000/29263 dt. 11.05.2000. The officials concerned may be allowed to exercise their options, if any, under FR-22 (1) a (1) within one month of issue of the order of granting the financial upgradation under the ACP scheme.
- (b) At the time of fixation of pay of the above employees, the DDO shall again confirm that the concerned officials either have completed at least 12 years of regular service with no promotion and 24 years of regular service with one promotion respectively.
- (c) The financial up-gradation is merely placement in immediate higher Pay Scale and does not amount to actual/functional promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees to whom financial up-gradation have been granted were not under currency period of penalty on the date from which financial upgradation have been granted to them.
