In continuation of this Office Memorandum No. DJB/AC(G)-I/C.G/2014/D-145 dated: 18/02/2014 and this Office Order No. 90(Dist.) dated: 11.06.2012, further consequent upon the approval of the Competent Authority vide orders dt. 12.02.2014, Sh. Neeraj S/o Lt. Sh. Hoshiyar Singh R/o H.No.381, Vill. Sersa, Distt.-Sonapat, Haryana-131028 has re-engaged as 'afresh' with immediate effect, on the post of Beldar on Muster Roll on Compassionate ground with the terms and conditions, his previous service is forfeited. Further, he is posted with EE(NW)-II subject to following terms and conditions:-

1. He/She will be governed by the rules and regulations as applicable to the other Muster Roll workers of Delhi Jal Board.
2. He/she will maintain the dependent/family of the deceased employee.
3. His/her engagement will further be subject to Verification of Educational and Caste Certificate and to the condition that nothing is found adverse about his/her character and antecedents, which will be got done by their DDO concerned within three months of his/her engagement. If any thing is found adverse about his/her character and past antecedents, his/her services shall liable to be terminated.
4. His/her engagement is further subject to the satisfactory work and conduct during the period of service.
5. He/She will not remain absent from duty for 30 days or more continuously, without prior approval of his/her controlling officer.
6. His/her pay will be fixed according to rules of M/Roll employees.
7. He/She will medically fit for the post as mentioned. If, he found not fit for the post then their services are to be terminate without further notice.
8. In case of failure on any of the above counts, M/Roll engagement shall liable to be terminated without notice.

Note: -DDOs are also hereby directed to complete the following formalities:-

1. Check the original certificate of educational qualification and other certificate, if any before taking him on duty.
2. Direct to individual to appear before the Medical Officer in DJB Dispensary for Medical examination with in 60 days and send the photocopy of MOI report to the Admn.
