Reg.:- Revision of the rates and slabs of Scholarship to the eligible employees of Delhi Jal Board for professing higher education to their children.

Delhi Jal Board vide its resolution No. 96 in the meeting held on 04.03.2014 has resolved to increase Bugdet provision under budget head 'Staff Welfare Fund (Scholarship Scheme for the children of Group C and D employees)' from Rs. 35 lac to 67 lac per annum and to revise rates and slabs of existing Scholarship Scheme as under:-

## B. Eligibility

i. Only group C and D employees with three years regular services and Muster Roll workers who have completed 240 days are covered under the scheme for payment of Scholarships to their children, studying from VI Class onward and who secured minimum 40% marks in the preceding year.

- ii. In case of girl child the minimum eligibility criteria of minimum marks 40% may be relaxed after seeking approval of the Competent Authority subject to securing minimum passing marks. Similarly, exceptional need cum merit case may be examined on individual basis on merit i.e. facts and circumstances of each case individually by the Scholarship Committee.
- iii. In case the number of eligible applicants is found on higher side in a year, wherein all these eligible employees are unable to cover within the provided budget, in such a situation all those eligible employees may be granted scholarship at the minimum laid down rates i.e. applicable to those securing up to 80% so as to cover all.
- iv. Employees whose children are getting reimbursement of Tuition Fees from Department are not entitled to get Scholarship.
- v. The ward of employees in receipt of scholarship/stipend/salary of any other financial support from the Central or State Government of from any source shall not be eligible for the Scholarship. But if the amount of such scholarship is less than the amount determined by the Delhi Jal Board, the DJB may award scholarship to the extent of difference.

The revised Scholarship Scheme will be effective from 2014-2015.
