TERMS & CONDITIONS

That he/she will have to support the family of his/her deceased Father/Husband failing which his/her services would be terminated without assigning any reason.

The appointment may be terminated at any time by a month notice by either side viz. the appointee or the appointing authority without assigning any reason, unless that the tenure of the post against which he/she is appointed/posted expires in which case the appointment shall be deemed to have expired on the date of expiry of the post without any notice.

The appointment carries with it the liability to serve in any part of the area under Delhi Jal Board.

That his /her engagement is further subject to the satisfactory work & conduct during the period of service.

If he/she remains absent from his/her duty more than 08 days without any information/permission, his/her services are liable to be terminated.

That his/her pay will be fixed according to rules.

That he /she will be governed by the rules and regulations as are made applicable to the other M/Roll workers of Delhi Jal Board.

Those muster-roll employees who appointed on Compassionate Ground and fail to produce the caste certificate/educational qualification certificate at the time of regular appointment in Delhi Jal Board will be treated as General category/illiterate employee and no benefit will be given in this regard.

Any muster-roll worker running absent from duty for 30 days or more, will not be taken on duty till specific approval from Competent Authority.

However, no extension for engagement on muster-roll has been granted in respect to those muster-roll workers whose name is not mentioned because their verification report along-with movement chart have not been forwarded by the concerned DDOs.
