- (b) At the time of fixation of pay of the above employee, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or he has spent 10 years continuously in the same grade pay for grant of benefit of 1st/ 2nd/ 3rd/ financial up-gradation under MACP Scheme without any break or unqualified service.
- (c) The financial up-gradation is merely placement in higher grade pay and this does not amount to functional/regular promotion or seniority benefit etc
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employees recommended for financial up-gradation were not under currency period of penalty. On the date from which financial up-gradation has been recommended/allowed to him.
- (f) The DDO concern shall also ensure/verify that none of the employee recommended by DSC has been granted any in-situ or other financial up-gradation under ACP scheme/promotion respectively.
