- (a) Pay & allowances of the incumbents will be fixed under the provisions of FR-22 (1) a (1) subject to the terms & conditions contained in DOPT O.M No. 35034/3/2008-Estt. (D) dated 19-05-2009. The officials concerned may be allowed to exercise their options, if any, under FR-22 (1) a (1) within one month of issue of the order of granting the financial up-gradation under the MACP scheme.
- (b) At the time of fixation of pay of the above employees, the DDO shall again confirm that the concerned officials either have completed 10/20/30 years of regular service or they have spent 10 years continuously in the same grade pay without any break.
- (c) The financial up-gradation is merely placement in immediate higher Grade Pay and does not amount to actual/functional promotion or seniority benefit etc.
- (d) The financial up-gradation is subject to verification of Audit.
- (e) The DDOs will verify that the employee(s) to whom financial up-gradation has/have been granted was/were not under currency period of penalty on the date from which financial up-gradation has/have been granted to him/them.


