- 1 Pay and Allowance of the incumbent will be fixed under the provisions of FR – 22 (I) a (1) subject to the terms and conditions contained in Dir(A&P), circular No. DJB/AC(W)/ACP/99/7377 dated: 30.11.1999 and clarification dated: 05.11.2000 and O.M. NO. 35034/3/2008 – Esstt. (D) Dated: 19/5/2009 of DOPT for MACP respectively. **The officials concerned may be allowed to exercise their option, for fixation of pay after accrual of increment in the lower grade. If any, under FR – 22 (I) a (1) within one month of the issue of the order for granting the financials up-gradation under the ACP/MACP Scheme.**
- 2 Before fixation of pay under ACP/MACP Scheme, DDO concerned shall ensure/verify that consdersd employee has completed 12,24 and 10/20/30 years of qualification service as on 09.08.1999 and 01.09.2008 respectively for granting benefit of 1st/2nd/3rd financial up-gradation under ACP/MACP without any break or unqualified service.
- 3 The DDO concerned shall also ensure/verify that the employee recommended by DSC has been granted any in-situ or other financial upgradation /promotion .Further explanation will be called for none submission of cases for granting financial up- gradation under ACP/MACP by the DDO in time.
- 4 The financial up-gradation is merely placement in immediate next higher grade pay and this does not amount to functional regular promotion or seniority benefit etc.
- 5 The financial upgradation is subject to verification by the Audit.
- 6 DJB employee, if any, in the list will be identified by the DDOs and processed separately as per different rules/ orders in such cases.
- 7 The DDO concerned shall Also ensure that the none of the employee recomonded by the DPC has earlier been granted same ACP/MACP be treated cancelled.

Note: -Antidating cases are those cases, wher earlier granted ACPs to DDA transferred employes were revised from the date of otheir intial engagement on workcharged.
