OFFICE ORDER No.88 (Min)

The Competent Authority vide orders dated 03.03.2014 has approved the reengagement of Shri Vijender Kumar S/o Sh. Ram Kishan as Computer Operator/Data Entry Operator purely on contract basis with immediate effect for a period up-to 30/6/2014 subject to the following terms & conditions:-

- 1. As per policy of contractual engagement the engagement will be purely on contractual basis and it will confer no right to appointment or regularization and placement in Delhi Jal Board, on any ground whatsoever.
- 2. As per policy of contractual engagement the period of engagement on contract basis may be extended (after giving 2 days break) or curtailed at the discretion of the Competent Authority.
- 3. As per policy of contractual engagement if any contractual employee remains absent from duty for more than 30 days continuously without any valid reason, then his/her contractual engagement will automatically stand discontinued.
- 4. As per policy of contractual engagement only one day C.L. in a month will be admissible to the contractual employees, which can not be carried forward to following months.
- 5. As per policy of contractual engagement the DJB reserve to right of assessing the out of Computer Operators every month which may be the basis for further continuance.
- 6. DJB will not hold any responsibility of incident/accident occurred to him during his/her period of services.
- 7. The department shall monitor his/her performance on the basis of satisfactory/unsatisfactory work and conduct report. His engagement on contract basis may be terminated at any time in case his performance/attitude is found unsatisfactory without any notice.
- 8. He will be paid remuneration on the basis of minimum wages act on the basis of order issued by Labour Department Govt. of NCT of Delhi i.e. Rs.9802/-P.M. only.

Further, Sh.Vijender Kumar, Computer Operator is directed to report to the office of Director (A&P) for further posting.
