In continuation of office order no. 41(Min.) dated 7/2/2014, the Competent Authority has approved the following terms & condition in case of engagement of 2 Nos. of Programmer i.e. (1) Ashish Kumar S/o Sh.Kamal Chand (2) Sh. Bal Krishan Prajapati S/o Sh. Tilakdhari C/o EE(EDP) Cell on contract basis through NIELIT:

- 1. The liability in respect of these Programmers will rest with NIELIT and DJB will pay a consolidated amount of (Rs.21563/-P.M. + NIELIT Charges 10% i.e. Rs. 2156/- + Service Tax) as applicable by the Govt. time to time and the payment will be made to NIELIT.
- 2. The services are borrowed for a period of Six months in the first instance from NIELIT.
- 3. As per policy of contractual engagement the engagement will be purely on contractual basis and it will confer no right to appointment or regularization and placement in Delhi Jal Board, on any ground whatsoever.
- 4. As per policy of contractual engagement the period of engagement on contract basis may be extended (after giving 2 days break) or curtailed at the discretion of the Competent Authority.
- 5. As per policy of contractual engagement if any contractual employee remains absent from duty for more than 30 days continuously without any valid reason, then his/her contractual engagement will automatically stand discontinued.
- 6. As per policy of contractual engagement only one day C.L. in a month will be admissible to the contractual employees, which can not be carried forward to following months.
- 7. As per policy of contractual engagement the DJB reserves the right of assessing the output of Programmers every month which may be the basis for further continuance.

- 8. The Programmer will work under the overall supervision of Dir.(F&A).
- 9. 5% annual increment will be given to Programmers, which will effect the NIELIT Charges and the Service Tax.
