It has been observed from time to time that the instructional orders are being issued by the Administration with the directions to all DDOs that transfer orders issued by the Administration must be complied in letter and spirit and any violation of this will be viewed seriously and the DDO concerned will be held responsible for the same.

The following Executive Engineers, Assistant Engineers and Junior Engineers of Delhi Jal Board were transferred from their present place of posting to new offices as mentioned against each. But these officials have not been relieved by their DDOs/Controlling Officers so far.

Now it has been ordered by the competent authority that the following officers/ officials who have been transferred from their present place of posting but not relieved till date due to one or other reasons shall stand relieved w.e.f. 03.03.2014(AN) and their pay and allowances shall not be released beyond the stipulated period as stated above. All the DDOs/Controlling Officers /Accounts Officers are directed to issue their LPC immediately and send a compliance report by 05.03.2014 positively, failing which the disciplinary action as deemed fit under CCS(CCA) Rules will be initiated against the DDOs/Controlling Officer/Accounts Officer on account of non-compliance of administrative orders.
