ORDER

This order shall dispose off the present appeal filed by Sh. Rakesh Kumar Chaudhary, R/o 5496, New Chandrawal, Ch. Bhim Singh Marg, Delhi-110007 on 14/08/2014 under the provision of Right to Information Act, 2005, against SPIO/ SR-V.

The said appeal was filed by Sh. Rakesh Kumar Chaudhary in respect of RTI ID No. Nil/ SR-V against the SPIO/SR-V. In this matter Notices were issued from the office of the First Appellate Authority on 27/08/2014 for hearing in this matter on 11/09/2014 at 12.00 Noon. On 11/09/2014 Sh. Rakesh Kumar Chaudhary was present and none appeared on behalf of the SR-V.

I have gone through the RTI application. The appellant vide his application dated 21-06-2014 requested for certified and attested copy of the document No.9553, Book No.1, Jilad No. 2907 Page Nos. 199 to 202. The PIO/SR-V is directed to forward the application of the appellant to the SR-VA where the information is apparently available. In fact, the SR-V should have transferred this application to the concerned PIO, which he failed to do. In future, if the information is not available with the PIO, it is the duty of the PIO to transfer the application to the concerned PIO where the matter pertains. Further, it is also directed that Sub Registrar-VA will provide the information to the appellant as available on record after receiving the application of the appellant from Sub Registrar-V. This process should be completed within 15 days of the receipt of this order. Appeal disposed off accordingly.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikamaji Place, new Delhi-110066, if he is not satisfied with the Orders of first Appellate Authority.
