ORDER

This order shall dispose off the present appeal filed by Sh. Dharam Pal Sejwal, R/o H.No. 224, Village Lado Sarai, New Delhi-110030 on 12/08/2014 under the provision of Right to Information Act, 2005. against SPIO/ SDM (HQ).

The said appeal was filed by Sh. Dharam Pal Sejwal in respect of RTI ID No. 10885/ SDM (HQ) against the SPIO/ SDM (HQ). In this matter Notices were issued from the office of the First Appellate Authority on 27/08/2014 for hearing in this matter on 16/09/2014 at 12.00 Noon. On 16/09/2014 Sh. Dharam Pal Sejwal was present and none appeared on behalf of SDM (HQ).

I have gone through the RTI application. The applicant was informed that his demand for alternative plot can be addressed by the Land & Building, which is the Nodal Department for the same.

The applicant was informed by the SPIO/ SDM (HQ) vide letter dated 14-07-2014 that the matter pertains to the Land & Building Department and was also informed that, in case, the applicant is not satisfied, he can appeal to the ADM who is the Appellant Authority for the RTI.

By this appeal, the applicant is not seeking any information and requesting for alternative plots which is a public grievance and can appropriately be addressed by the Land & Building Department. Accordingly, he is requested to approach the Land & Building Department for the same. Further, the SPIO/SDM (HQ) is directed to provide the relevant information as available on record within 10 days of receipt of this order. Appeal disposed off accordingly.

The RTI application was filed by the applicant to the SPIO/SDM (HQ) on 23-05-2014 and the information was provided by the PIO on 14-07-2014 and was delayed by 52 days. As per the provisions of the RTI Act 2005, the information is to be provided within 30 days of receipt of the RTI. The SPIO/SDM (Saket) to ensure that information is provided in a time bound manner.

Further, the Appellant will be at liberty to approach to Central Information Commission, Room No. 296, August Kranti Bhawan, Bhikamaji Place, new Delhi-110066, if he is not satisfied with the Orders of first Appellate Authority.
