Public Notice in the leading newspapers for awareness of the lessor and the lessee about registration fee of the lease and consequences of non-registration has been finalized & will be published in the leading newspapers. A specimen copy of advertisement is enclosed. Futher vide letter dated 13/02/2014(copy enclosed), this office has requested to all concerned including DMRC, three MCD & NDMC that while entering into lease deed/agreements to charge requisite stamp duty on the instrument for registering the same as per section 17 of the Registration Act. Not doing so causing revenue loss to the treasury. A copy of the relevant extract of the report has also forwarded to them & details of such instruments are also uploaded in Revenue Department website with http://www.revenue.delhi.gov.in.lt has also been requested to ensure strict compliance with the provisions of the status as indicated including past transactions also.

2. Short Levy of duty & incorrect exemption allowed on the instruments etc.

In this regard this department has already intiated action by asking all Cllector of Stamps/Sub Registrar that the instruments mentioned in the performance appraisal on "Levy & Collection of Stamp Duty and Registration Fee" of AGCR and uploaded on the departmental website for assessing deficient stamp duty as per provisison ofd the act. Final report after receiving communication from the COS will be sent to AGCR shortly.

3. Matter regarding launching web based software for collection of stamp duty on Shares/debentures has been finalized & the same has been put up in trial by the department. Once trial is successfully completed & security audit is done, the same will be launched after taking approval of Competent Authority. In the meantimes, the department is issusing notices to all concerned for recovery of stamp duty on share certificates on the basis of information gathered from MCA.
