**ORDER**

Consequent upon implementation of recommendation of 6<sup>th</sup> Pay Commission vide GOI Notification No. G.S.R. 622 (E) dated 29/08/2008 and endorsed by Finance (Budget) Department, Govt of India vide letter No. F.11(4)/2006-Fin.(B)/dsFB/1746 dated 09/09/2008, the Pay of Dr. Anil Agarwal, Addl. Secretary (Revenue)/ADM (H.Q.) is fixed upon exercising option for pay fixation w.e.f. 01/01/2006 in PB-3 (Rs. 15,600 -39,100/-) with Grade Pay of Rs. 5400/- as detailed under:-

Further, in pursuance of M/o Home Affairs, Govt. of India Notification No. 14016/18/2009-UTS-II dated 23/11/2011 vide which Dr. Anil Agarwal, Addl. Secretary (Revenue)/ADM (H.Q.) has been appointed to the Selection Grade of Services in the Pre-revised pay scale of Rs. 10,000-325-15200 w.e.f. 01/07/2006, the pay of the Officer is fixed as under:-
