The above allocation of funds is subject to the following conditions:-

01. As per the Finance (Budget) Department, Government of NCT, Delhi letter No. F3(1)/2014-15 Fin./USF(B)/684 dated 25.03.2014, "Vote on Account" for the month of April, 2014 to September, 2014 has been voted by the Parliament and relevant "The Delhi Appropriation (Vote on Account) Act, 2014 has also assented to by the President of India and the Department can incur expenditure out of the Budget Estimate 2014-15 for the period April to September, 2014 subject to observance of prescribed procedure. However, the total expenditure should not exceed ½ of the total Budget Estimates 2014-15 of the Department, since the "Vote on Account" includes on half of the estimated provision for the whole year.

As such the condition as laid down by the Finance (Budget) Department, GNCT, Delhi vide letter No.F3(1)2014-15/Fin./USB(B)/684 dated 25.03.2014 shall be complied strictly.

02. All codal formalities, as per GFR etc shall be completed before incurring expenditure.

03. The expenditure shall be incurred with the prior approval of the authority competent to sanction it.

04. The funds shall be utilized only for the purpose it is being provided.

05. Necessary Utilization Certificate along with details of expenditure incurred as per the approved estimates shall be obtained on utilization of funds on completion of the deposit work and copy of the same shall be submitted to this office.
