It has been observed that the Collectors of Stamp are still issuing challans to the public directing them to deposit the stamp duty in SBI, Tis Hazari, Delhi. This is being done inspite of the instruction issued vide this office letter no. F. 1(7)/Misc./SDM(NL)/2013/943, dated 12.7.2013 (copy enclosed) that the requisite stamp duty may be taken in the form of estamp paper.

The deposit of stamp duty through the challan system in SBI, Tis Hazari, Delhi not only cause delay and inconvenience to the general public but also defeat the purpose of e-stamping.

All the Collector of Stamps are accordingly directed to collect the stamp duty through e- stamp only as verification of e- stamp can be done on system only by locking the e- stamp for which user –ID & password has been given for each COS. This will also reduce the unnecessary correspondence with Pay & Account Office & facilitate the public at large. In case any clarification, COS may contact SDM-II (HQ).

This instruction may be followed strictly.
