
Reference to this office letter no. F.1(488)/GA/Estt/DC/06/5129 dated 12/06/2014 & subsequent reminder-I letter no. F.1(488)/GA/Estt/DC/06/5454 dated 09/07/14 & reminder-II letter no. F.1(488)/GA/Estt/DC/06/5765 dated 31/07/2014 on the subject cited above, it is submitted that no reply has been received till date in this regard.

Further, it is also to mention here that it has been stated by the Finance Accounts Department that as per the existing instructions of Govt. of India on the subject, 90% of temporary posts upto the level of Deputy Secretary to the Govt. of India (PB-3 Rs.15600-39100 + G. Pay Rs.7600/-) can be converted into permanent ones, provided they have been in existence for a continuous period of not less than 3 years and as per the instructions issued by FD vide OM No. F.15/1/2011-AC/DS.III/671 dated 23/05/2011, the conversion of temporary posts is required to be considered with reference to the nature of work. Also the scheme/ project for which posts were created involves work/ activity of continuing nature, the posts can be converted into permanent ones.

Therefore, it is again requested to provide the details of the temporary posts which are in existence for a continuous period of not less than 3 years and it may be noted that the conversion of temporary posts is required to be considered with reference to the nature of work. And also the scheme/ project for which posts were created involves work/ activity of continuing nature, then the posts can be converted into permanent ones.

This may be treated on TOP priority basis.


