
Sir,

Please refer to letter no. TOK/CONS/551/1/2014 dated 16.10.2014 from the Deputy Chief of Mission, Embassy of India, Tokyo ( copy enclosed) on subject regarding non issue of Death Certificates in r/o Sh. Bhagwan Singh and Smt. Nariyan Devi, missing persons of Haryana State in Uttarakhand Disaster during June 2013 .

In this regard it is informed that Death Certificate No. DL-90 in r/o Sh. Bhagwan Singh s/o Sh. Lalii Singh and Death Certificate No. DL-91 in r/o Smt. Nariyani Devi w/o Bhagwan Singh were received from Uttarakhand Government but vide letter no. F.1 (127)/ddma(hq)/LMPU/PF-I/2013/241 dated 06.05.2014, these were returned to the Chief Secretary, Uttarakhand Government in original along with compensation amount in respect of above said persons vide letter No. F.1/68/DDMA(HQ)/Cheque/Uttarakhand/2013/874-78 dated 09.05.2014 because during verification it had been found that the address of residence of above mentioned persons was C-1852, Ansal Palam Vihar Gurgaon, Haryana and details of these persons could not be verified as belonging to other state i.e. Haryana.

It is, therefore, requested to appraise the Deputy Chief of Mission, Embassy of India, Tokyo about the status of issue of death certificates in respect of Sh. Bhagwan Singh and Smt. Nariyani Devi under intimation to this office.
