In continuation to this office order of even number dated 16/09/2013, all the Sub Registrars (SRs) are once again informed that the Hon'ble High Court in W.P. (Civil) No.7057 2005 titled Court on its motion V/s Delhi Development Authority (DDA) & Ors has issued the following directions:-

- 1 The DDA shall make available on its website the information regarding DDA lands along with Khasra number and area.
- 2 The SRs shall first go to the website and verify whether documents that are presented for registration pertain to any of the Khasra Nos. of the lands of the DDA. In case the land belongs to DDA the documents shall not be registered.

It is further informed that details of all above information as provided by the DDA in the form of Compact Disc have also been placed on the departmental website i.e. <http://www.revenue.delhi.gov.in>.

All the Sub Registrars are hereby once again directed to first go to the website of DDA as well as of this department and verify whether documents that are presented for registration pertain to any of the Khasra Nos. of the lands of the DDA & in case the land belongs to the DDA, the documents shall not be registered.

All the Registrars/Sub Registrar shall follow these instructions meticulously.
