**ORDER**

On the recommendation of the Departmental Screening Committee constituted for the grant of Financial up-gradation under the Assured Progression Scheme/Modified Assured Progression Scheme to the ex-cadre officials and officials re-deployed from DEDA on the strength of the Revenue Department and in accordance with the instructions contained in OM No.35034/3/2008-Estt(D) dated : 19.05.09 of the Govt of India, M/O Personnel Public Grievances and Pensions (Deptt of Personnel & Training), endorsed by Finance Deptt. Gndt. Delhi vide No.F.11(4)/2008/Fin.B/Pt-II/DSFB/1192-1197 dated 27-05-09 and in pursuance to the Revenue Department, GNCTD order No.F.23(171)/GA/Estt./DC/2011/2074 dated 07/10/13 **Sh. Dharam Pal, Despatch Rider** on completion of 30 years of regular service for grant of 3rd up-gradation from the corresponding Pay Band-II to the immediate next higher grade pay i.e. Rs. 2400/- in the hierarchy of the recommended revised pay band w.e.f. 24.06.2011. The vigilance clearance report in r/o **Sh. Dharam Pal, Despatch Rider** has been received from the vigilance branch, of this Department. As per the vigilance report, there is no case is pending **Sh. Dharam Pal, Despatch Rider**. Further **Sh. Dharam Pal, Despatch Rider** has also exercised the option under FR-22 that his pay be fixed under the MACP scheme after granting annual increment on 01.07.2011. 4.	Pay after granting financial benefits under MACPS i.e. 3% increment on amount at Sr. No. 3 with grade pay of Rs. 2400 w.e.f. 01.07.2011	Rs. 9510 (Basic Pay) + Rs. 2400 (Grade Pay)
5.	Pay as on 01.07.2012	Rs.9870 (basic Pay) + Rs. 2400 (Grade Pay)
6.	Pay as on 01.07.2013	Rs.10240 (basic Pay) + Rs. 2400 (Grade Pay)
7.	DNI	01-07-2014
