ORDER

Attention of all the schools (Govt./Aided/unaided) is hereby invited towards the safety and security of the students using private transport arranged by parents to ferry children to school.

In this regard, Delhi Police raised the issue of private transport arranged by parents to ferry children to school in the meeting held under the Chairmanship of the Joint Secretary (UT), Ministry of Home Affairs on 20th August, 2014 and stated that records of such transport and crews should be maintained in the school.

Necessary directions had already been issued to all Private Recognized Unaided schools vide this Department's Circular bearing NO.DE.15(330)/Act-I/2013/24140-24145 dated 10-06-2014 to take the list of drivers and conductors engaged in such vehicles and get them verified by Delhi Police and compliance report in this regard may be submitted in respective zonal offices of this Directorate within one month of issue of Circular.

Further vide this office circular bearing NO.DE.15(330)/Act-I/2013/25641-25646 dated 13-08-2014 all Private Recognized Unaided schools were once again directed to submit the compliance report to their respective zonal offices of this Directorate immediately.

As discussed in the meeting held on 20th August 2014, it has been decided to issue appropriate instructions to the school management to collect the data of such private vehicles, including the name and addresses of the drivers and helpers deployed on such private transport engaged by parent groups.

Therefore, all the schools(Govt./ Aided/Un-aided) are hereby directed to maintain the data in the enclosed format and submit the same in respective zonal offices of this Directorate within one month of issue of this order.

All the Deputy Directors of Education shall compile the data received from the Zones and forward the same (alongwith soft copy) to this branch for onward submission to Delhi Police for taking further necessary action at their end.

Further all the Heads of (Govt./Aided/Un-aided) schools are hereby directed to advise the parents of the students studying in their schools during the Parents Teachers Meeting regarding the safety and security of their children who use private vehicle to ferry them to **coaching classes**, if any.
