ORDER

Hon'ble High Court vide Order dated 30.09.2014 in WPC - 1225/2014 titled Pramod Arora Vs Hon'ble Lt. Governor of Delhi has further directed that Directorate of Education shall also provide the information regarding-

1. The number of seats in respect of the kind of disability which each particular unaided school is geared or equipped to cater to;
2. The facilities specifically existing for that purpose;
3. The fees to be charged from the pupils by such school; and
4. The fees for disabled students' vis-à-vis fees charged from other students.
5. Obtain and furnish information with regard to the number and type of Special Educators / Teachers in each Unaided School which has facilities for disabled children. ***[Copy of the order dated 30/09/2014 received on 09/10/2014 is enclosed.]***

DoE has to submit the report in the third week of this month in the Hon'ble Court by way of filing the affidavit.

It is, therefore, directed as under:

1. Those Unaided Private Schools of Delhi which have already informed to this directorate in response to Order No.DE-15/Act-1/WPC 1225/14/2014/26252-257 dated 11/09/2014 that they have facilities to cater to the needs of 'Disabled Children' to fill up the **format -'D' annexed with this order** and submit the same **in duplicate** to **Education Officer/zone concerned by 15/10/2014.**
2. All Education Officers will, thereafter, consolidate/fill up the information submitted in formats 'D' by the above said Unaided

Private Schools of his/her zone in the **Column numbers 05 to 10 of the lists of schools provided with this order** which are catering to the special needs of the disabled children. The district-wise lists of the said Unaided Private Schools are also forwarded to each DDE on their e-mail IDs for expediency.

One set of Formats 'D' may be kept by EOs concerned for record and other set of **the formats -'D'** alongwith **completed and signed lists** shall be forwarded to DDE concerned **by 17/10/2014.**

3. All DDEs will forward the said list/s of Unaided Private Schools of all zones of his/her district alongwith one set of Formats 'D' submitted to EOs of his/her zone **to Act -1 branch, Room Number 229, DoE, Old Sectt. Delhi by 20/10/2014.**

These being the Time Bound Directions of the Hon'ble High Court of Delhi, shall be given TOP PRIOTITY and NON-COMPLIANCE/ANY DELAY of these orders will be viewed seriously.

1. The Government of National Capital Territory of Delhi (GNCTD) has filed the affidavit; the affidavit of the Nodal Officer, directed to be appointed by this Court, has also been shown. The same is not part of the record. The affidavits show that some action has been taken by the GNCTD in gathering information with respect to various private aided schools that cater to people with different kinds of disabilities. Furthermore, the GNCTD also appears to have created a format of application, copy of which is part of Nodal Officer's affidavit.

2. During the course of hearing, it was noticed that the common form for applying for admission in entry level classes of specially abled/ disabled children to unaided recognised schools of Delhi, in Column 15, refers to the list of schools offering facilities to children with different disabilities. However, the list provided in the affidavit placed on record by the Government does not specify the number of seats, and other facilities, available in each such school.

3. In these circumstances, the GNCTD is hereby directed to:

- (i) Issue appropriate directions under Rule 43 of Delhi School Education Rules and/ or Section 12(3) of The Right of Children to Free and Compulsory Education Act, 2009, and elicit all the requisite information with regard to:

- (a) The number of seats in respect of the kind of disability which each particular unaided school is geared, or equipped to cater to;
 - (b) The facilities specifically existing for that purpose;
 - (c) The fees to be charged from the pupils by such schools;
 - (d) The fees for disabled students vis-a-vis fees charged from other students.
- (ii) Issue all appropriate directions to ensure even distribution of availability of seats for children with different disabilities – as far as it is practicable – in the different districts/ zones of Delhi. This is to ensure minimal hardship to the children, who might otherwise have to travel long distances, just to attend the school.
- (iii) Obtain and furnish information with regard to the number and type of special educators/ teachers in each unaided school, which has facilities for disabled students.
- (iv) Indicate all the necessary information to enable the parents of the child to opt appropriately; such information shall be provided on the website of the GNCTD with proper links to the concerned schools, who may have their own websites.
- (v) The above information shall be collated and necessary amendments/ changes to the application form carried out within the next three weeks.
4. All unaided private schools are hereby directed to cooperate in the
