Schools shall extend full co-operation to the Inspection Team and produce such certificates / documents related to admission for the inspection of the Team.

On the basis of the findings of the Inspection Team, suitable action will be taken by the DDE concerned against such school / parent who committed any violation of the admission criteria or manipulation of documents.

Such violation or manipulation will invite strict action against the school management under the provisions of the Delhi School Education Act and Rules, 1973. Further this will also lead to cancellation of the candidature/admission of the ward and penal action against the parents of the ward under the relevant provisions of law.
