ORDER

'Inter State Transfer Case' criterion was introduced as one of the admission criteria for open seats in the entry level classes in Recognized Unaided Private Schools with the intention that people in transferable jobs coming from different cities are hard-pressed for finding suitable schools and therefore, due weightage needs to be given for Inter State Transfer cases.

During the admission process, the Directorate of Education received number of complaints/representations alleging that some of the parents are misusing the 'Inter State Transfer Case' points for taking undue advantage.

The Directorate of Education, after taking cognizance of complaints/representations, constituted Inspection Teams in every district of the Directorate to assess the quantum of applications in 'Inter State Transfer Case' category and genuineness of the documents submitted in this regard. On perusal of the sample data collected by the Inspecting Team it has been observed that approximately 50% of Open seats are claimed by the applicants of 'Inter State Transfer Case' category, which implies that the persons having only 'Neighbourhood' points were not getting adequate chance of being included in the draw of lots.

Some of the aggrieved parents also approached the Hon'ble Delhi High Court by filing a Writ Petition (Civil) No. 1266/2014 titled Sudhanshu Jain Vs. Lt. Governor of Delhi & Ors. The Hon'ble High Court vide order dated 26.02.2014 in the above said WPC directed State Govt. to take a decision with regard to Inter State Transfer Category and to issue a fresh schedule for draw of lots by 27.02.2014.

In compliance of the above said order of the Hon'ble Delhi High Court, the Hon'ble Lt. Governor, after analyzing the sample data, has decided to do away with the 'Inter State Transfer Case' criterion having assigned 05 points from the point system for admission into entry level classes of Recognized Unaided Private Schools. Accordingly, a notification No.F.DE.15/1031/Act-I/Part-I/2014/21626-37 dated 27.02.2014 has been issued.

Pursuant to the above said notification, following directions are hereby issued to Recognized Unaided Private Schools of Delhi for strict compliance: -

 With the deletion of points of 'Inter State Transfer' cases, the points shall be determined only as per 'Neighborhood', 'Sibling studying in school' and 'Parent Alumni of School' criteria.

- The list(s) already declared by the school till date will now get modified to the extent that those seats assigned earlier to 'Inter State Transfer Case' category applicants shall stand vacated.
- 3. If the school has conducted draw of lots for those applicants securing 70 points, that draw shall remain valid for the selected/confirmed candidates only. Fresh draw of lots shall be held for remaining applicants having 70 points, including wait listed applicants and those applicants who were earlier securing 75 points because of 'Inter State Transfer Case' category.
- 4. The last date of display of first list, including EWS and DG category, is extended to 15th March, 2014. The date of display of second list, if any, will be 20th March, 2014. The date of displaying of subsequent list(s), if any, will be from 21st March, 2014 to 31st March, 2014. The admission Process shall close on 31/03/2014.

This issues with the prior approval of the Competent Authority.
