ORDER

The Hon'ble High Court of Delhi vide Order dated 12.03.2014 in L.P.A. No. 237/2014 titled Nitin Bhatia Vs Major Saurabh Charan & Ors, has Ordered as follows :-

"fresh draw of lots in terms of the order dated 06.03.2014 and Lieutenant Governor's Notification dated 17.02.2014 shall not take place and no admission be made till the next date"

Further, the Hon'ble Delhi High Courts in the aforesaid L.P.A. has asked the data with regard to the nursery admission in respect of the recognized unaided private schools.

The recognized unaided private Schools of Delhi are hereby directed to comply with the above mentioned Order of the Hon'ble Delhi High Court.

In another writ petition 1225/2014 titled 'Pramodkumar Vs Hon'ble LG & Anrs, the Hon'ble High Court vide Order dated 12/03/2014 has directed to furnish the information in r/o facilities available in schools for the disabled children with special reference to nature of disability(s).

Therefore, the Heads of Schools of all the recognized unaided private Schools of Delhi are hereby directed to provide the information regarding ongoing nursery admission process and facilities available in schools for the disabled children with special reference to nature of disability(s) on the online module on this directorate's website - www.edudel.nic.in by 03:00 P.M. of 18th March 2014 strictly.

The online module would be available and operational by 15.03.2014 and can be accessed through following path - www.edudel.nic.in → Log in (with school ID and password) → School Plant → information regarding ongoing nursery admission 2014-15 etc.

In addition, the above information is also to be submitted (hard copy) in the enclosed Performa, duly signed and stamped by the Head of School, to the Deputy Director of Education of the concerned district along with documents & details of applicants under Inter State Transfer category which are not found genuine by 5:00 P.M. of 20th March 2014.

Non compliance would be viewed seriously and Hon'ble High Court would be apprised accordingly.



During the course of hearing the learned counsel for the Government
of NCT submitted that the following information will be furnished after
collecting all relevant data:-

1. The ^① total number of available seats to be filled in the entry level in all
recognised schools in Delhi (Government aided, local authority-managed)

and private unaided institutions). This information shall also set out the necessary break-up in terms of each category.

2. Particulars with respect to the nature of special facilities extended by different institutions i.e. Government aided, local authority-managed and unaided institutions. In these particulars the Government of NCT shall categorise the kinds of educational institutes that are spelt out in section 2(cc) of the Persons with Disability Act and section 2(d) of the Right to Education Act, 2009.

3. Suggestions as to the best possible methods to maximise the chances of children with different kinds of disabilities and categorise all possibilities for admission and if possible to allow particular institutions to admit within the 75% quota earmarked for general category candidates.

The Government of NCT shall file a proper affidavit indicating its stand with respect to the issue of whether within the 75% quota, the 3% and further reservations under the Disabilities Act can be worked out to the advantage of those covered by the said enactments.



Interim order to continue.


