Subject:- information regarding ongoing admission process and facilities available in the schools for disabled children with special reference to nature of disability -Clarification.

Reference to this Directorate's order No. DE.15/1031/Act-I/Part-I/2014/22129-22140 dated 14.03.2014 vide which Private Unaided Recognized schools were directed to provide the information regarding ongoing admission process and facilities available in the schools for disabled children with special reference to nature of disability on the Online Module available on this Directorate's website www.edudel.nic.in by 3.00 PM of 18th March 2014.

- 2. Till date only 567 schools have provided the information but the perusal of the information indicates that the desired information, with specific reference to 'number of children that can be taken as per the available facility for disabled' in entry level class(s) of school under the heading 'Facility Available for Disabled Children in School' has not been filled by the school.
- 3. In view of above, it is clarified that the information desired, with specific reference to 'number of children that can be taken as per the available facility for disabled' **means** the number of children with a particular disability which a school can admit, in entry level class(s), considering the facilities available in school for that particular disability.
- 4. Therefore all the 567 schools which have filled incorrect information as mentioned above are directed to resubmit/refill the desired information as clarified above under the Heading 'Facility Available for Disabled Children in School' by **Editing** it in online module by 11.00 AM of 21st March, 2014 strictly.
- 5. Further, the private unaided recognized schools which have not furnished the desired information on the online module till date are hereby once again directed to provide/fill the desired information keeping in view the clarification given in para 3 above by 11.00 AM of 21st March, 2014 strictly failing which action as deemed fit shall be initiated against the erring schools.
- 6. The desired information is being asked in pursuance of the Hon'ble High court order in WP(C) 1225/2014 and L.P.A. No. 237/2014, therefore any default in this regard would be viewed seriously and the Hon'ble Court would be apprised accordingly.
