ORDER

The Division Bench of the Hon'ble Delhi High Court vide their Order dated 03.04.2014 in the matter LPA No. 237/2014 titled 'Nitin Bhatia Vs Major Saurabh Charan and Ors.' has directed that:

"In other words, the first part of condition 3 of the notification dated 27.02.2014 would operate with full vigour. Insofar as the second part of condition 3 of the notification dated 27.02.2014 is concerned, we would defer our orders till the next date of hearing.

In the meanwhile, however, all those applicants who have been selected pursuant to the draw of lots concluded till date in more than one school, should, on or before 09.04.2014, choose one school thereby vacating the seats for the other schools. In case this choice is not made on or before 09.04.2014, they shall lose their right to any admission. The Directorate of Education shall collect the data from all the schools which shall fully co-operate with the Directorate of Education.

Till the next date of hearing no fresh draw of lots shall take place. The admission process in respect of those persons who have been permitted to be selected as above shall be completed and concluded. This order modifies the previous orders passed by us as also the impugned order."

Pursuant to above said Order/directions, following guidelines are hereby issued to unaided recognised public schools of Delhi for strict compliance for admission to the entry level classes for the academic session 2014-2015:



- 1. The Notification No F.DE.15/1031/ACT-1/Part-1/2014/21626-37 dated February 27, 2014 issued by the Directorate of Education, GNCT of Delhi has been upheld by the Hon'ble Court in so far as it relates to the deletion of the 5 points for 'Inter State Transfer' cases.
- 2. The <u>first draw of lots</u>, for applicants with 70 points, held prior to Order No F.DE. 15/1031/ACT-1/Part-1/2014/21645-56 dated February 27, 2014 issued by the Directorate of Education, shall remain valid.
- 3. The <u>first draw of lots</u>, for applicants with 70 points, conducted by some schools after 27th February 2014 i.e. after scrapping of 'Inter State Points', considering all 75 points applicants (Neighbourhood + IST points) as applicants having 70 points, shall also remain valid.
- 4. Any subsequent or second draw of lots for 70 point candidates conducted after notification dated 27th February 2014, stays "**on hold**" till next hearing by the Hon'ble High Court, which is scheduled on April 16, 2014. Also, no further draws for 70 points is to be conducted until the date of next hearing.
- 5. All candidates with 75 points and above (except Inter State Transfer points) i.e. candidates with sibling, alumni points who have been selected till date shall also remain selected. Further candidates under girl's quota, staff quota and EWS and Disadvantaged group quota shall also remain selected as it is.
- 6. All applicants who have been selected in more than one school under the open seats category are required to make a final selection of ONE seat by making payments of fees by April 09, 2014, failing which applicant shall lose his/her right to any admission.
- 7. The schools shall start the admission process immediately keeping in view the above said directions and complete the admission process in respect of open seats, staff quota, girl's quota and EWS & Disadvantaged group quota by 9th April 2014. Considering the paucity of working days available with schools to complete the process, the schools may continue the admission process on holidays as well.
- 8. The schools shall not consider the wait listed applicants for admission till next date of hearing by the Hon'ble High Court and further directions in this regard.
- 9. The schools may start classes for the admitted students by 15th April 2014.

10. All schools are directed to furnish the requisite data (in the format given in annexure 'A') by April 12, 2014 on the link to be made available and active on Directorate of Education's website www.edudel.nic.in after login in (through school ID and password) → School Plant → information regarding admission granted till 9th April 2014.
