ORDER

Hon'ble Supreme Court of India vide judgment dated 07.05.2014 in Civil Appeal No.5379-5380/2014 (Arising out of Special Leave Petition(c) Nos.10265-10266 of 2014) in the matter of Major Saurabh Charan and others V/s Lt. Governor, NCT of Delhi & ors has directed as -

"In the circumstances, we direct that the admissions already granted to the **appellants' children** shall not be disturbed on the basis of impugned Notification dated 27th February, 2014 deleting points for Inter State Transfer. These children shall continue their study in those schools where they got admitted or selected for admission."

"In course of argument, Mr. Gupta, learned senior counsel appearing for the appellants, furnished a list of 22 parents having 24 candidates belonging to Inter-State Transfer category, who are successful under Notification dated 18th December, 2013. Learned senior counsel submitted that these candidates are also entitled to get admission and continue study in those schools."

"Therefore, we direct that these **24 candidates shall get admission**, if not at all admitted, being the successful candidates under the Inter-State Transfer category under Notification dated 18th December, 2013. It goes without saying that the Administration shall take steps to accommodate these students in various schools within its jurisdiction by increasing the number of seats in such schools. However, it is made clear that this order would only enure to the benefit of those who had approached the Court. It would certainly not extend the benefit to those who had not approached the Court or might have gone in slumber.

With the aforesaid directions and observations, these civil appeals are disposed of. Consequently, the writ petitions and the appeals pending in Delhi High Court also stand disposed of."

Pursuant to the above said Judgement, following directions are hereby issued to Unaided Recognised Public Schools of Delhi for strict compliance for the admissions to the entry level classes for the academic session 2014-15:-

- The Notification No F.DE.15/1031/ACT-1/Part-1/2014/21626-37 dated February 27, 2014 issued by the Directorate of Education, GNCT of Delhi vide which the 'Inter State Transfer Case' points was done away with, is valid for all the applicants except 24 children of 22 appellants (list annexed) who have approached the Hon'ble High Court Delhi/Supreme Court of India.
- The entry level admissions given by the schools till 09/04/2014, in compliance of the order of the Directorate of Education No. F/DE/15/1031/ACT/2014/22663-75 dated 04.04.2014, are valid.
- 3. The Hon'ble Supreme Court vide above mentioned judgement also disposed off the pending writ petitions and appeals in Hon'ble Delhi High Court in this regard. Therefore, the Unaided Recognised Public Schools shall complete the process of admissions of remaining seats, which were kept vacant in view of Order of the Hon'ble High Court dated 03.04.2014 in LPA 237 & 238 of 2014. These seats shall be filled immediately by conducting the draw of lots, if required, on the basis of Directorate's direction No. 3 of this order F.DE.15/1031/Act-1/2014/21645-56 dated 27.02.2014.
- 4. The counsel for the appellants in the said SLP supplied a list of 24 children in the Hon'ble Supreme Court, claiming that these children were successful/selected for admission in entry level class for the session 2014-15, on the basis of 'Interstate Transfer Case' points in Unaided Recognised Public Schools. The Directorate of Education, GNCT of Delhi is not aware of the had fact that whether appellant's children been successful/selected for admission in schools in which they are claiming to be selected. Therefore, the HOS/Management of the schools are directed to give admissions to the above said 24 children (list annexed) after ensuring that they are successful/selected for admission in their schools prior to issuance of notification dated 27.02.2014. They are to be admitted either against vacant seat(s), if available or by creating extra seat(s) if vacant seats are not available as per the directions of the Hon'ble Supreme Court of India.

Further, the above said 24 children of 22 appellants who have been selected in more than one school are required to make a final selection of ONE seat by making payments of fees and completing the formalities of admission by 12/05/2014 (Monday).

Accordingly, the unaided recognised public schools shall start the classes for the admitted children at the earliest possible.

This issues with the prior approval of the Competent Authority.
