CIRCULAR

Sub: Extension of provisional recognition granted upto Elementary level under RTE Act, 2009 for further period of six months beyond 31-03-2014.

In accordance to sub-rule (7) of Rule 14 of Right of Children to Free and Compulsory Education Act, 2009 as amended vide this office Notification bearing No.DE.15 (206)/Act/2013/7902-7916 dated 25-03-2013 all such schools which applied online were to be issued a certificate in Form-IIA by the Director Education, GNCT of Delhi, which shall be valid for a period of one year or till the order to the contrary is passed by the appropriate authority, whichever is earlier.

Accordingly provisional recognitions were granted to schools up to Elementary level for a period of one year w.e.f. 01-04-2013 to 31-03-2014 by Directorate of Education, GNCT of Delhi on the basis of applications filled by the schools up to 15-02-2014.

Since the time was short for completing the inspection work of all the schools to which provisional recognitions were granted for a period of one year w.e.f. 01-04-2013 to 31-03-2014 by district authorities, as well as keeping in view the Board Examinations, it has been decided by the competent authority to extend the period of provisional recognition for a further period of six months i.e. up to 30-09-2014 for smooth conducting of inspections by the district authorities and further processing of files at HQ level.

Accordingly the period of provisional recognition in r/o those schools to whom provisional recognition up to Elementary level was granted up to 31-03-2014 under RTE Act, 2009 is hereby further extended upto 30-09-2014.

No action will be initiated against unrecognized schools found functioning from academic year 2014-15 on wards i.e. 01.04.2014 under the provisions of RTE Act, 2009 till the extended period.
