**CIRCULAR**

Hon'ble High Court of Delhi in Civil Writ Petition No. 1225/14 titled Pramod Arora Vs Lt. Governor, Delhi & Ors vide order dated 07.05.2014 has directed as under:-

*".....In the light of these and considering the fact that finalization of admission process is imminent in view of the orders of the Supreme Court, the Govt. of NCT of Delhi is directed to issue an appropriate circular to these 15 schools to reserve at least 2 seats for Children With Special Needs for the current academic year 2014-15 at the nursery level."*

In pursuance of the aforesaid order, the 15 private unaided recognized schools are hereby directed to reserve at least 2 seats for the Children with Special Needs in their schools in Nursery Class for the academic year 2014-15. Further, other schools as mentioned by the Petitioner in the aforesaid Writ Petition are also directed to reserve the same number of seats for the said category of children in said class till further orders.
