ORDER

The Hon'ble High Court of Delhi vide its order dated 05/08/2014 in WP (C) 3684 of 2014 in the matter of Justice for All Vs Govt. of NCT of Delhi has directed the Director of Education to file an affidavit within two weeks indicating, therein, total number of children, who are admitted for the current academic year i.e. 2014 -15 in Unaided Recognized Private Schools, Government schools and government aided schools of Delhi under Economically Weaker Section and Disadvantaged Group category, are being provided free books and uniforms by the schools concerned.

In this regard, three formats have been prepared (annexed) to gather the requisite information from schools / Education Officers / Districts for onward submission to the Hon'ble Court.

Accordingly, it is directed as under:-

1. **Managers / Principals** of all private unaided schools to furnish the requisite and authentic information in Format 'A' in DUPLICATE to the office of respective **Education Officer** by **11/08/2014** (4 P.M.).
2. **All Education Officers** will-
 - (a) Check and consolidate the information provided by the Private Unaided Schools falling under their respective jurisdiction, in format 'B' and submit the same to DDE concerned on or before **13/08/2014** (4 P.M.) along with one set of format of each school. Another set of the format may be retained by the zone itself.
 - (b) Provide the TOTAL ENROLLMENT of children of classes FIRST (from Pre-School/Pre-primary if available) to EIGHTH of all **Government Schools** AND **GOVERNMENT AIDED SCHOOLS** *separately* of their respective zones for the current academic session i.e. 2014-15 in **Part 3 of format 'B'**.
3. **All offices of DDEs** will further consolidate the requisite information provided by the all zones under their jurisdiction in format 'C' and send the same to ACT - 1 branch, room number 229, Directorate of Education, Old Secretariat, Delhi on or before **16/08/2014** (5 P.M.)
