**ORDER**

Hon'ble High Court vide order dated 01.09.2014 in WPC - 1225/2014 titled Pramod Arora Vs LG of Delhi has directed that Zone-wise / District-wise inspection of the Unaided Private Schools be carried out by the department to check the facilities available in these schools to cater to the special needs of the 'Disabled Children' and to submit the report in the Hon'ble Court **before next date of hearing i.e. 27/9/2014.**

It is, therefore, directed as under:

1. All Unaided Private Schools of Delhi to fill up the **format -1** annexed with this order and submit the same **in duplicate** to concerned zone **by 12/09/2014.**
2. All Education Officers will, thereafter, immediately check the facilities available in these schools to verify school's claims and if found correct then compile the information received from the Unaided Private Schools in **format -2** and submit that with one set of format -1 to DDE concerned **by 15/09/2014.** Other set of the formats -1 submitted by these schools shall be retained by the Zonal offices for record.
3. All District DDEs may further physically counter check the said facilities in Unaided Private schools if felt necessary and compile the data received from their respective Education Officers in **format -3** and send the format -3 with one set of formats -1 received from Unaided Private Schools to Act -1 branch, Room Number 229, DoE, Old Sectt. Delhi **by 17/09/2014.**

These, being the Time Bound Directions given by the Hon'ble High Court of Delhi, have to be given TOP PRIOTITY and NON-COMPLIANCE of these orders will be viewed seriously.
