SHOW CAUSE NOTICE

Whereas public distribution system is regulated under Essential Commodities Act 1955 (10 of 1955).

And whereas the Authorization of FPS is regulated under Clause 6&7 provisions of Delhi Public Distribution System (Control) order 2001 and Delhi Specified Articles, (Regulation of Distribution) order, 1981.

And whereas the FPS holder is bound to comply with the Terms & Conditions laid down in the said Act and Order and various instructions issued by the Competent Authority from time to time under the said Act and the Orders.

And whereas a team of inspectors of , Food & Supply Department visited the business premises of FPS No. 8535-M/s.Musrrat Jahan ,1054,Phatak Ramakrishna Das chitilikavar ,Jama Masjid, Delhi at 12.35 on 01-05-2014 for conducting inspection. Following discrepancies were found:-

1. No Sugar sample was there.
2. List of BPL/AAY Cardholder was not displayed.
3. The verification of Weighting and Measuring instrument on the date of inspection was not available.
4. Total variation of 0-11 Kg.(short) of Sugar come into the notice of Inspecting Team.

And whereas by committing the above irregularities the FPS holder has violated the provisions of Delhi Specified Articles (Regulation of Distribution) Control Order, 1981 and Public Distribution System (Control) Order, 2001.

Now, therefore, Authorization holder FPS No. No. 8535-M/s.Musrrat Jahan ,1054,Phatak Ramkishan Das chitilikavar Masjid, Delhi is hereby directed to show cause as why the license/authorization may not be suspended/cancelled under Clause 4(1) and entire security money be forfeited under Clause 4(2) of Delhi Specified Articles (Regulation & Distribution) Order, 1981 for the above lapses. The authorization holder of FPS No No. 8535-M/s.Musrrat Jahan ,1054,Phatak Ramkishan Das chitilikavar, Jama Masjid, Delhi. is hereby directed to appear in person or through authorized representative for personal hearing **within three (03) days of issue of this Notice** along with his explanation failing which decision will be taken ex-parte in the circumstances of the case without any further reference.
