## SHOW CAUSE NOTICE

Whereas public distribution system is regulated under Essential Commodities Act 1955 (10 of 1955).

And whereas the Authorization of FPS is regulated under Clause 6&7 provisions of Delhi Public Distribution System (Control) order 2001 and Delhi Specified Articles (Regulation of Distribution) order, 1981.

And whereas the FPS holder is bound to comply with the Terms & Conditions laid down in the said Act and Order and various instructions issued by the Competent Authority from time to time under the said Act and the Orders.

And whereas a team of inspectors of, Food & Supply Department visited the business premises of FPS No. 3072-M/s.Om Parkash Sohan Lal, 10313.Motia Khan, Jhandewalan, New Delhi at 02.15 pm on 01-05-2014for conducting inspection. Following discrepancies were found:-

- 1. No Statutory Boards except Stock Board was found displayed at the business premises.
- No Cash Memo was made available by the Helper/labour of FPS hence the same could not be recovered.
- 3. Total Seven (7) food cards were also found inside the FPS detail of which is given in Recovery-cum-Counting -cum-Weightment-Memo.
- Some other documents viz-a-viz Adhar Card, EPIC(photocopies/òriginal) were also found inside the FPS,
- Total variation of 1.87 Qtl. In stock of SFA as per physical verification of stock and the relevant records of the FPS was found..

And whereas by committing the above irregularities the FPS holder has violated the provisions of Delhi Specified Articles (Regulation of Distribution) Control Order, 1981 and Public Distribution System (Control) Order, 2001.

Now, therefore, Authorization holder FPS No No. 3072-M/s.Om Parkash Sohan Lal, 10313.Motia Khan, Jhandewalan, New Delhi i is hereby directed to show cause as why the license/authorization may not be suspended/cancelled under Clause 4(1) and entire security money be forfeited under Clause 4(2) of Delhi Specified Articles(Regulation & Distribution) Order, 1981 for the above lapses. The authorization holder of FPS No. 3072-M/s.Om Parkash Sohan Lal, 10313.Motia Khan, Jhandewalan, New Delh. is hereby directed to appear in person or through authorized representative for personal hearing within three (03) days of issue of this Notice along with his explanation failing which decision will be taken ex-parte in the circumstances of the case without any further reference.
