SHOW CAUSE NOTICE

Whereas public distribution system is regulated under Essential Commodities Act 1955 (10 of 1955).

And whereas the Authorization of FPS is regulated under Clause 6&7 provisions of Delhi Public Distribution System (Control) order 2001 and Delhi Specified Articles (Regulation of Distribution) order, 1981.

And whereas the FPS holder is bound to comply with the Terms & Conditions laid down in the said Act and Order and various instructions issued by the Competent Authority from time to time under the said Act and the Orders.

And whereas a team of inspectors of, Food & Supply Department visited the business premises of FPS No. 6081-M Mukesh Kumar Lalita Prasad.A-427,Krishna Basti,Amar Puri,Nabi Karim,New Delh-110055 at 11.45A.M on 01-05-2014 for conducting inspection. Following discrepancies were found:-

1. No Statutory Boards except Stock Board was found displayed at the business premises.
2. At some instances of entry for the month of April, 2014 in Stock Register white Fluid has been used which is not permissible.
3. The ambience of FPS was found displayed.
4. Helpline No. was not found displayed.
5. The list of Food Cards was not found displayed.
6. The samples of SFAs were not found displayed.

And whereas by committing the above irregularities the FPS No. 6081-M Mukesh Kumar Lalita Prasad.A-427,Krishna Basti,Amar Puri,Nabi Karim,New Delh-110055 holder has violated the provisions of Delhi Specified Articles (Regulation of Distribution) Control Order, 1981 and Public Distribution System (Control) Order, 2001.

Now, therefore, Authorization holder FPS No. of FPS No. 6081-M Mukesh Kumar Lalita Prasad.A-427,Krishna Basti,Amar Puri,Nabi Karim,New Delh-110055 holder is hereby directed to show cause as why the license/authorization may not be suspended/cancelled under Clause 4(1) and entire security money be forfeited under Clause 4(2) of Delhi Specified Articles(Regulation & Distribution) Order, 1981 for the above lapses. The authorization holder of FPS No. 6081-M Mukesh Kumar Lalita Prasad.A-427,Krishna Basti,Amar Puri,Nabi Karim,New Delh-110055 is hereby directed to appear in person or through authorized representative for personal hearing within three (03) days of issue of this Notice along with his explanation failing which decision will be taken ex-parte in the circumstances of the case without any further reference.
