Sub: Sale of Non PDS items through Fair Price Shops.

Sir,

In supersession of letter No. F 3 (08)/2005/ F&S/P&C/160-169 dated 06/02/2014 and all other instructions issued on the subject previously, it has been decided to allow the licensee of FPS to sell all the non PDS items through FPS outlets to improve the viability of Fair Price Shops. However, the sale of the following items through FPS outlet is strictly prohibited:-

- (i) Wheat flour and Wheat maida
- (ii) Rice flour and Suji
- (iii) All explosive items which require License for sale/stock
- (iv) Drugs, Alcohol and alcoholic Substances
- (v) Poisonous substances such as insecticides, pesticides, rodent killer, fungicides
- (vi) Items which make the SFA unfit for consumption either by odour or by physical mixing.
- (vii) Eatables items which require preparation on the spot such as Halwai Shop, Dhaba, Tea Stall etc.
- (viii) Meat & meat products

The sale of non PDS items is subject to the following conditions:

- (i) The items which require license can be sold only after obtaining requisite license from the respected agency.



- (ii) The storage capacity for SFA shall not be compromised by the FPS holder, he/she shall have to maintain sufficient space for storage and sale of SFA.
- (iii) The storage capacity for SFA should be sufficient to accommodate the one month allocation capacity at the least.
- (iv) In the pretext of permission of sale of other items, he/she shall not be allowed to keep/store SFA at any other place.

It is therefore, requested that the above decision of Competent Authority may be communicated to all the FPS Licensees functioning under your jurisdiction. A compliance report may be sent by 15/09/2014.

This may be treated as **MOST URGENT**.
