The main points of the meeting are as follows:-

- CFS inquired about the progress of proof of concept for implementation of POS at FPS. Sh. B.K. Luthra, Senior Manager (NISG) apprised the concept of POS implementation. It was informed by Virgo representative that the software for connectivity is being developed by NIC central team for browser based POS device.
- 2) As the browser based devices are not readily available and developing software and configuring the machine may take time. CFS wanted that the proof of concept may be done with available stand alone devices and the department can opt for browser based devices (if required) in the RFP for full implementation of POS devices for all FPS. CFS telephonically discussed the matter with Ms. Ranjana Nagpal, DDG, NIC about the issue and she also agreed that the proof of concept of POS can be implemented on standalone devices.
- 3) The vendor (Virgo Softech Ltd.) was directed to co-ordinate with Sh. Ajay Chhakara, Sr. Techincal Director, NIC to sort out all issues.
- 4) Sh. Ajay Chhakara, Sr. Technical Director, NIC will be nodal point as far as Food & Supplies Department is concerned and sort out issues out of the development of the software and co-ordinate with the central team, vendor and UIDAI for successful implementation of POS in two shops latest by the last week of Feb 2014.

 CFS also desired that functions of the concept may be demonstrated in the office of CFS within one week.

The meeting ends with a vote of thanks to the chair.
