## ORDER

In pursuance of paragraph 6(3) of the Annexure to the PDS (Control) Order 2001 regarding formation of Vigilance Committee on TPDS by the concerned State/UT Government, the Commissioner, F&S, is pleased to constitute the District Level Vigilance Committee with immediate effect. The Composition of the District Level Vigilance Committee will be as under:

- 2. The main objective and the functions of the District Level Vigilance Committee will be as under:
  - (i) The District Level Vigilance Committee shall be authorized to redress/solve the problems at its level to the maximum extent possible and whenever it is not possible, it would refer the same with its recommendation to the State level Committee.
  - (ii) To watch and suggest measures for prevention of the cases of short supply, less weighment, over-charging and distribution of sub-standard quality of SFAs by holders.
  - (iii) To suggest measures to prevent the issuance of bogus cards.
    - To supervise regularly the implementation of all schemes under the National Food Security Act 2013.
    - To inform the District Grievance Redressal Officer in writing of any violation of the provisions of National Food Security Act 2013.

- (vi) To inform the District Grievance Redressal Officer in writing of any malpractice or misappropriation of funds found by it.
- 3.(i) It shall be mandatory to hold meeting of the Committee at-least once in two months and minimum quorum required for the meeting will not be less than 50% of the total number of the Committee members.
- (ii) Copy of the minutes of the meeting of District level Vigilance Committee will be drawn formally and circulated to all the members. Recommendations and reports will be sent to the Commissioner, F&S for necessary action. All the reports, recommendations and suggestions should be made collectively by the Committee and recorded by the Member Secretary.
