ORDER

1. In pursuance of paragraph 6(3) of the Annexure to the PDS (Control) Order 2001 regarding formation of Vigilance Committee on TPDS by the concerned State/UT Government, the Chief Secretary, Govt. of NCT of Delhi is pleased to constitute the State Level Vigilance Committee with immediate effect. The Composition of the State Level Vigilance Committee will be as under:

Note:-Out of the above, atleast one member each from Scheduled Caste/Scheduled Tribes, Women, Minorities and destitute person or persons with disability category should be a member of the Committee.

2. The main objective and the functions of the State Level Vigilance Committee will be as under:

- (i) The Committee shall review quarterly the overall functioning of TPDS Scheme in the State and difficulties being faced, if any, in smooth functioning of the Scheme in the State as a whole.

- (ii) The Committee/ its members may also visit PDSs and Offices of Food & Supplies Department, meet beneficiaries of the Scheme and may recommend the State Govt. corrective action for any problem in implementation of TPDS.
- (iii) If any decision in any issue is in jurisdiction of Central Govt., the State Level Committee shall recommend corrective action to the Central Government.
- 3.(i) It shall be mandatory to hold meeting of the Committee at-least once in three months and minimum quorum required for the meeting will not be less than 50% of the total number of the Committee members.
- (ii) Copy of the minutes of the meeting of State Level Vigilance Committee will be drawn formally and circulated to all the members. Recommendations and reports will be sent to the Chief Secretary, Delhi for necessary action. All the reports, recommendations and suggestions should be made collectively by the Committee and recorded by the Member Secretary.

This issues with the prior approval of Chief Secretary, Delhi.
